Ground Floor

Entrance Hallway

A composite double glazed front door, UPVC double glazed side window, tiled flooring, gas and electric meter cupboard and wall light.

Lounge

UPVC double glazed front window and secondary glazing, wood burning stove with feature stone fireplace, radiator, wood panel walls, TV point, ceiling beams, ceiling point and oak stairs leading to the first floor landing.

Range of wall and base units with complementary worksurface, four ring gas hob, electric oven, plumbed for washing machine, single bowl sink unit with drainer, parts tiled walls, combi boiler, tiled flooring, radiator, ceiling points, rear window with secondary glazing and back door.

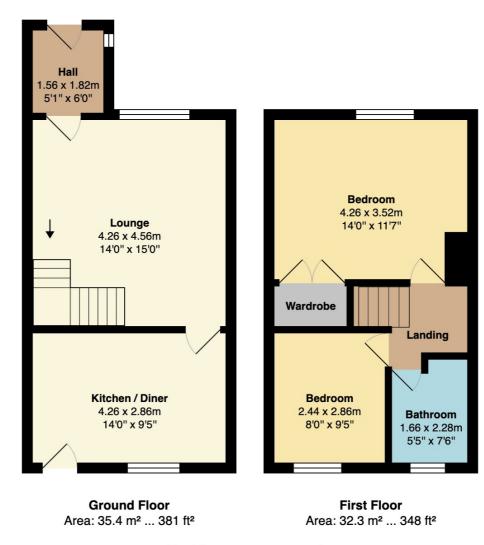
